Welcome Address:

Honourable Vice Chancellor, Prof. (Dr.) Udai Singh Rawat, Chairman of the Research Committee extended the inaugural address of the meeting with hearty welcome to the external experts and all other members of the Research Committee in the Ninth Research Committee meeting.

The chair highlighted the SGRR University achievements in Research and Innovation. The university is emerging as a lead centre of research, innovation and extension programs. The University has attained 38 research projects funded by Govt. and Non-Govt. organisations. The robust research culture is substantiated

by the attained development projects, publications, patents etc. The University has attained Rs. 23+ crores of development projects. SGRR University is diligently working to develop a multi-institutional niche for research & innovation by extending the linkages and inking the MoUs with the leading HEIs. The University is being recognised at state and national level with 36 MoUs and multiple research linkages. The output of the research has been a significant achievement in terms of patents and publications. The SGRR University has published more than 25 patents with 08 being awarded. The University has published more than 1400+ publications in 05 years with 750+ publications indexed in UGC care listing/SCOPUS/WOS/Pubmed/NMC list/NAAS. Further, in a nascent stage of 5 years, the SGRR University has become a choice centre for Ph.D. Programs. The University has conferred 32 doctoral degrees under Ph.D. program.

The chair deliberated the efforts that the honourable management has invested in developing a vibrant research and innovation ecosystem. The research incentive scheme, research & development seed money policy etc. are being implemented generously to facilitate the innovative ideas and develop the proof of concept. The faculties are duly recognised for the valuable efforts by the management, to keep them motivated for research along with academics.

Thereafter, the chair invited Dr. Lokesh Gambhir, member secretary of the research committee to take the proceedings ahead with the circulated agenda points.

Initiating the proceedings of the day, Dr. Lokesh Gambhir started the discussion on agenda points.

The following agenda items were discussed in the meeting:

Agenda 1: To consider confirmation of minutes of 9th Research Committee meeting held on 29/03/2022.

All members were informed that the Minutes of the meeting of Research Committee of Shri Guru Ram Rai University, held on 29th March 2022, have been duly circulated to all via email and no inputs/suggestions were received. Dr. Lokesh Gambihr again presented the gist of the proceedings of the 9th Research Committee meeting along with the follow up action in front of all the members of research committee. All the members of the committee gave their consent for the same.

Resolution: The committee resolved to confirm the minutes of 9th Research Committee Meeting held on 29th March, 2022.

Resolution: The committee resolved to confirm the action taken report on minutes of 9th Research Committee Meeting held on 29th March, 2022 with appreciation.

Agenda 3: To consider the amendment in Ph.D. ordinance in coherence with the UGC regulation for Ph.D., Nov 2022.

Dr. Lokesh Gambhir apprised the committee members about the need of amendment in the Ph.D. Ordinance as per the UGC regulations released in November 2022. The ordinance was circulated to all the members via mail on 09th March, 2023 for the inputs. Dr. Lokesh Gambhir presented the amendments in the ordinance in fornt of the committee and asked for the inputs. The external expert Prof. H.S. Nainwal and Prof. J.S. Chauhan provided their valuable suggestion on each Research Rule in the Ph.D. Ordinance. The Committee had a thorough discussion on every research rule presented in the Ph.D. ordinance amendment 2023 (Annexure I). Briefly, following points were discussed along with the amendments incorporated in the Ph.D. ordinance.

RR-1: Eligibility Criteria for Applications

1.1 and 1.2 are revised as per the UGC regulation. Further, as per the suggestion of Prof. H.S. Nainwal the eligibility of candidates for the Ph.D. program is redefined with minimum of 55% marks without grace marks. 1.3 shall include other suitable disciplines along with engineering and pharmacy. Section 1.3.3 shall be removed from the ordinance pertaining to the exemption of senior citizens from the RET.

RR-2: Duration of the Program

Paternity leave of 15 days to the research scholars shall be included along with the maternity leave under section 2.3 of RR-2.

RR-4: Registration/Admission after Interview

Section 3.8 shall be removed from the Ph.D. ordinance as the recommendation to modify the title and the proposed plan of research work comes under the duties of Synopsis Approval Committee as per the Ordinance. Section 3.3 shall clearly narrate that the date of registration for a research scholar should be the date of admission in Ph.D. program.



RR-5: Eligibility criteria of research supervisor

Section 4.1 should include the eligibility of medical science courses. As apprised by Prof. Pankaj Kumar Garg that the MD/MS with ten years of experience shall be the guideline for the recognition as research supervisor. The chair further asked the house regarding the NMC guidelines. It was apprised that the NMC guidelines have been released as a draft only with 15 years of experience. After discussion committee concluded that the criteria of 10 years may be changed as and when the regulations of NMC are released in the gazette.

Dr. Lokesh Gambhir raised the prevailing doubts in the medical research supervisors concerning the recognition of the research supervisors to the chair and the committee members.

For recognizing the research supervisors in the SGRRIMHS, SGRR University, Ph.D. ordinance guidelines approved by the Research Committee followed by the Board of Management and Board of Governors approval, shall be strictly followed. The research supervisors recognised in the SGRRIMHS shall be allotted research scholars of both clinical and non-clinical background. The MD/MS candidates for the Ph.D. program shall come under clinical whereas non-medico courses shall come under non-clinical. The clinical background students after attaining Ph.D. are eligible for showcasing the same in NMC.

RR-6: Course work of the Ph.D. registered research scholar

Prof. H.S. Nainwal suggested incorporating the provision of blended teaching in case of pandemic scenario for the Pre Ph.D. course work.

RR-7: Synopsis Approval Committee composition:

Prof. Kumud Saklani apprised the BOS of the Ph.D. shall govern the approval of the research topic and proposal. The detailed list then shall be submitted to the research office for the approval in the research committee. The committee after a exhaustive discussion raised the concerns about frequent conduction of SAC (twice a year for every discipline) which is not feasible in form of BOS. Further, the chair narrated that the SAC is a regulatory body with defined composition superseding the BOS of the respective Ph.D. discipline. Dr. Lokesh Gambhir narrated that the external experts in the SAC are invited as per the research domain of the proposals which may be difficult to attain by BOS.

After having extensive discussion, the committee agreed that at present the status quo may be kept same.

RR-8: Progress Report:

Prof. H.S. Nainwal suggested incorporating the period of 01 month for the unsatisfactory progress report as the extension to submit the report including the suggestions.

RR-11: Format for thesis:

Section 11.1.4 pertaining to optimal length of the thesis of 150-200 pages may be omitted from the ordinance. Dr. Lokesh Gambhir further bought in notice the section 11.2.1 narrating the need to publish 02 research papers in UGC listed journals as a mandate for the thesis submission. The new UGC guidelines have no mention of the publication as mandate for thesis submission. The committee with extensive discussion agreed that the 02 UGC listed journals shall be a mandate for the Ph.D. thesis submission to enhance the research output and upgrade the research ecosystem.

RR-13: Evaluation:

A

Prof. H.S. Nainwal suggested decreasing the time given to the candidate to incorporate the corrections in the evaluated Ph.D. thesis and submit for viva voce examination. For major revision the period finalised by the committee is 60 days. Further, for the rejection of thesis by any one of the three examiners, the thesis may be sent to the fourth examiner for evaluation. The positive reports of the fourth examiner will lead to the scheduling of the Ph.D. viva voce examination. However, on attaining the reports of rejection from the fourth examiner, Dr. Lokesh Gambhir shall put up the file for the discretion of Honorable Vice Chancellor. Further, if two examiners out of the initial three examiners have rejected the thesis, then the research scholar will be declared ineligible for the award of Ph.D. degree

RR-13: Plagiarism and subsequent actions:

Prof. H.S. Nainwal suggested constituting a departmental/school wise research ethics committee for detecting and underlining the plagiarism in the Ph.D. thesis. The unsatisfactory/disputed cases shall be put through the School Research Committee followed by the SGRR University Research Ethics Committee. The decision of the University research ethics committee pertaining to the plagiarism will be abided by the Honorable Vice Chancellor.

Resolution: After extensive discussion, the committee resolved to confirm the amendments with incorporating the suggestion in the meeting. The Dr. Lokesh Gambhir after incorporating the suggestions shall present the Ph.D. ordinance amendment 2023

Agenda 4: To consider the allotment of Research Scholars, Batch-VIII (2022-2025) to eligible Ph.D. supervisors of the University.

Dr. Lokesh Gambhir placed the list of allotted Ph.D. supervisors for the research scholars; batch VIII, for consideration before the members of the Research Committee. It was informed to the committee that the weightage to student's choice of supervisor as per UGC guidelines and consideration of the supervisors' research area with the availability of the seats has been taken into consideration for the allotment.
