

Resolution: It was resolved to approve the SGRRU Ph.D ordinance.

Agenda 2: Considered the credit score for Course work.

Resolution: It was resolved that the credit score for course work as recommended by the BOS of the respective faculties to be followed.

Agenda 3: Considered the availability of Ph. D seats in various Faculties of University. (Annexure-II)

Total number of Ph. D seat available in various faculties was presented. Dr. Amit Verma suggested that there should be Ph. D seat allocation to Medicine Department of SGRRIM&HS. Dr. P.P. Dhyani, appreciated and directed to look into the MCI guidelines for adequate provisions to be made. He also suggested to emphasize on quality Interdisciplinary Research and also to develop a Research culture in the University.
