

Dean-Research, Dr. Arun Kumar informed all about the proposed Training & Research Policy of the university for External Research scholars along with the course wise applicable fee. In this regard Dr Amandeep Singh suggested that the Animal House

- 1. Prof. Preeti Kothiyal submitted to the house that there should be minimum (wo research committee meetings in one financial year (01st April to 31st March). All members unanimously agreed upon it.
- 2. Dr. S. C. Pachauri raised query regarding remuneration for the Ph.D supervisors. Prof. J.P. Bhatt strongly opposed it and expressed his anguish for the same. He urged all present to whole heartedly involve in developing a research culture at the university.
- 3. Dr. Pachauri requested to consider allotment of designated room for research scholars in all departments. The suggestion was well taken by all and decided to discuss the matter with Honorable Vice Chancellor for further necessary approval.
- 4. Dean Research informed all that one research scholar is interested to register in Physiotherapy since no approved supervisor in physiotherapy is available with the university; Prof. J. P. Bhatt suggested that in such case supervisor from any other allied department may be considered for approval. It may be noted such supervisor should fulfill all the eligibility requirements as per UGC guidelines. All members concurred with the suggestion.

Reporting Items:

- Research informed the house that RET-III was conducted on 08/10/2018 and 72 candidates attended the examination for the admission in various Ph.D programmes. 48 candidates were declared qualified for the registration. All members expressed satisfaction over the same.
