Prof (Dr.) S. R. Singh (external expert) and Prof. (Dr.) Amit Varma, could attend the meeting. Prof. (Dr.) M. S. Kandpal (University, Academic Coordinator) attended meeting as a special invitee. Dr. Arun Kumar (Dean-Research) welcomed external expert and all other members in the sixth Research Committee meeting.

The following agenda items were discussed in the meeting:

Agenda 1 & 2: To consider confirmation of minutes of 5^{th} Research Committee meeting held on 03/08/2019 & action taken report.

It was informed to all members that the Minutes of the meeting of Research Committee of Shri Guru Ram Rai University, held on 3rd August 2019, have been duly circulated to all via email on 07/09/2019 & no inputs were received. Dr. Arun Kumar presented the gist of the proceedings of the 5th Research Committee meeting along with the follow up action. Prof. J. P. Bhatt (external expert) raised the query upon Plagiarism detection software and said that as it was committed by Dr. Arun Kumar in last Research Committee meeting that university will purchased Plagiarism detection software very soon. Is it purchased or not? Dean Research informed the house that URKUND Plagiarism Detection Software (PDS) full version was received from UGC on 01 September 2019 free of cost and all research supervisors are registered on it. Dr. Arun Kumar also confirmed the house that all Ph.D research scholars shall be registered very soon on URKUND. Prof J.P Bhatt and other members felt extremely satisfied upon it. Dr. Kumud Saklani (Dean I/C, School of Basic and Applied Sciences) sent a suggestion via e-mail after the meeting that Head of the department of respective school should be the Chairperson of Synopsis Approval Committee (SAC), as matter was not discussed in front of all committee members so Dean Research ensured Dr Kumud Saklani that it would be discussed in next Research Committee meeting. She agreed on it. All the members reviewed the minutes thoroughly and expressed satisfaction on rest of the follow up action initiated by Dean-Research.

Resolution: The minutes of 5thResearch Committee Meeting and follow up action were unanimously confirmed by the house.

Prof. (Dr.) Anil Mehta (Dean, School of Medical & Health Sciences) also supported his views that Prof. Bhaskar Charan Kabi fulfills all requirements as per MCI guidelines, other members also agreed on their views.

Agenda 6 & 7: To consider various funding agencies for the submission of research proposals for the development of research infrastructure of the university.

Dr. Arun Kumar informed honorable house members and specially all Deans & Deans I/C of respective schools that you have to motivate their faculty members to submit major and minor research proposal for funding to various Government and non Government private organizations (NGOs) like: UGC, DST, DBT, USERC, UCOST, ICMR, ICAR, NBA & GB Pant etc so that robust research infrastructure could be developed in the university. Dr. Kumud Saklani raised query upon it and said that at this stage we do not have 12b status of UGC so we are not eligible for obtaining research funding from Government agencies. Prof. J.P. Bhatt opposed her statement and said we can obtain research funding from Government as well as from NGOs at this stage and said your job is to submit research proposal, nobody can stop you and all faculty

members of Shri Guru Ram Rai University are competent enough for sending research proposals so keep going and submit best research proposals for various funding agencies. Prof. M. A. Beg informed house members that many faculty members of Medical & Health Sciences presently receiving heavy amount of funds from various funding agencies like; DST, USERC, UCOST & ICMR etc. Prof. J.P. Bhatt also suggested that funding agencies prefer interdisciplinary subjects for granting funds. Prof. Manoj Rana, Prof. Malvika Kandpal, Prof. Deepak Sahni, Prof. S. C. Pachauri, Prof. Anil Mehta & Dr. Kunal Kishore seconded this.

Resolution: It was resolved to approve that all deans/ Deans I/C will encourage their faculty members to submit good research proposal to various funding agencies.

All members reviewed the status of the seats for their respective college and appreciated the same. Dr. Arun Kumar invited suggestions on the point where existing supervisors have resigned from their posts then who will be the supervisor for the Ph.D scholars allotted to them. Prof. J.P. Bhat, Prof. S.C. Pachauri, Prof. Manoj Gahlot and Dr. Kumud Saklani suggested that there should be an internal co-supervisor along with supervisor, in case supervisor resigned then co-supervisor may take care of his/her research scholar till further appointment of supervisor. Prof. Manoj Rana suggested that for the time being Dean of concerned school may be the administrative co-supervisor of the research scholars where no supervisor is available. Prof. J. P. Bhatt highlighted that co-supervisor should be from the same discipline particularly in this case and where supervisor is available then co-supervisor may be from interdisciplinary subjects. Prof. J.P Bhatt suggested that this matter should be discussed in Academic council and BOG meetings.
